The Skoda Superb was introduced in Australia and New Zealand in March 2016. This ANCAP safety rating applies to all two-wheel-drive variants built from 2016, when a driver knee airbag became standard. This includes the Combi (wagon) variant.

Dual frontal, side chest and side head airbags (curtains) and a driver knee airbag are standard. Advanced seat belt reminders are fitted to all seats. Autonomous emergency braking (AEB) is standard in Australia but the city system was not tested by Euro NCAP. See page 2 for other safety features.

In the offset crash test driver chest and leg protection was acceptable. In this test passenger leg protection was also acceptable, In the side impact crash test driver protection was good. Chest protection in the side pole test was acceptable.

The passenger compartment held its shape well in the offset test. Pedal and steering wheel displacements were well controlled. Driver and passenger contact with the airbags was stable. All doors remained closed during the crash. After the crash all doors could be opened with normal effort.


Pedestrian Protection.

Pedestrian Test

This vehicle scored 25.66 out of 36 points (Acceptable). The bumper provided predominantly good protection to pedestrians' legs. The Superb scored maximum points for the protection it offered to the pelvis area. The bonnet surface offered protection that was predominantly adequate with some weak or poor results seen on the stiff bonnet edges and windscreen pillars. (Tested by Euro NCAP v8)
