The tested model of Suzuki Vitara was introduced in Australia and New Zealand in mid-2015. This ANCAP safety rating applies to all front-wheel-drive variants excluding Turbo variants. Other variants are unrated.

Dual frontal, side chest, side head-protecting (curtain) airbags and a driver knee airbag are standard. Advanced seat belt reminders are fitted to all seats. A full list of safety features and technologies can be viewed within the *Safety Features & Technologies* table on page 2 of this report.

Occupant Protection.

Frontal Offset Test

Each body region is scored out of 4 points

Head / neck:	4.00 points
Chest:	3.15 points
Upper legs:	4.00 points
Lower legs:	3.64 points

The passenger compartment held its shape well in the frontal offset test. Pedal and steering wheel displacements were well controlled. Driver and passenger contact with the airbags was stable. All doors remained closed during the crash. After the crash all doors could be opened with normal effort.

Side Impact Test

Each body region is scored out of 4 points

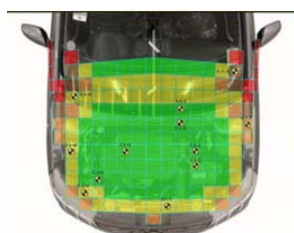
Pedestrian Test

This vehicle scored 28.60 out of 36 points (Good). Most locations provided good protection for a struck pedestrian. Some locations at the base of the windscreen pillar and around the headlights performed poorly. (v8.3)
